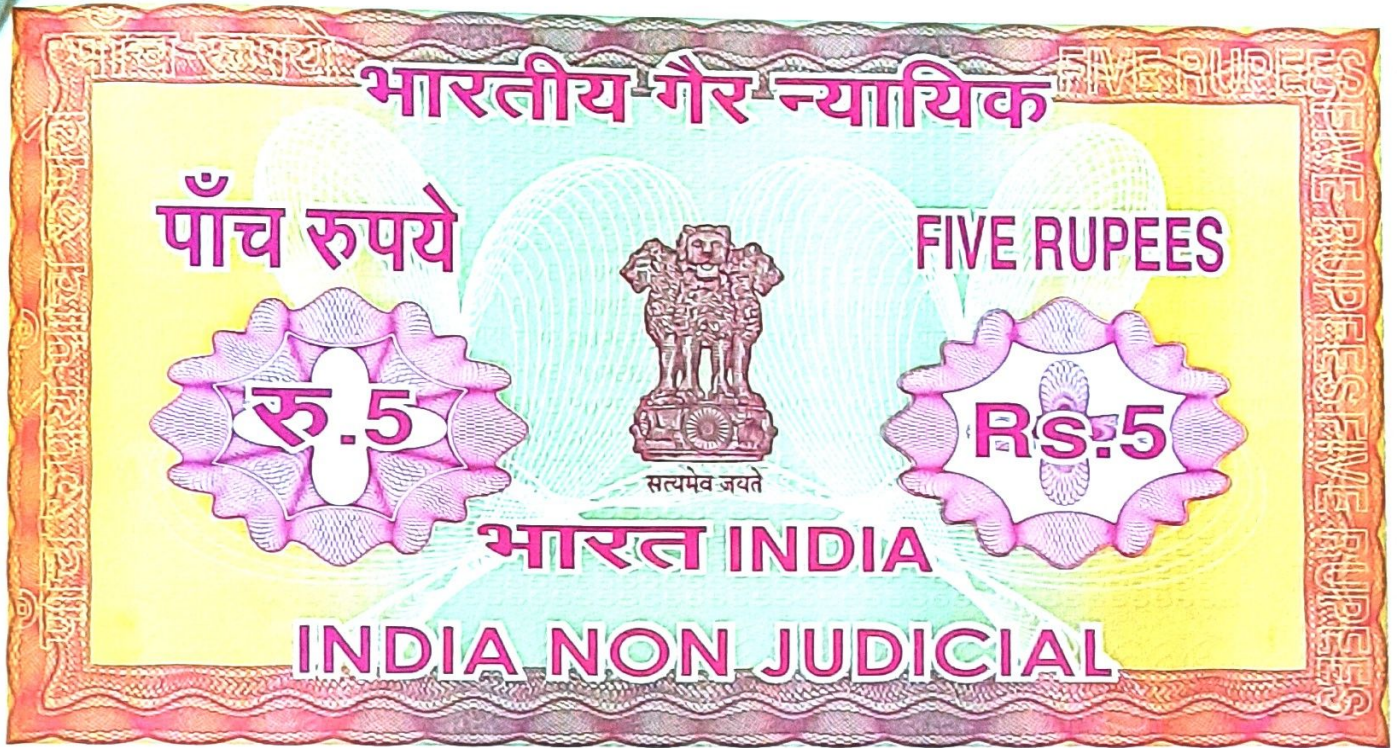
Whereas the above named I & II parties have joined hands to carry on business of Coaching and Consultancy and other related works w.e.f. 03-12-2010.


